Bay Capital is an experienced, full-fledged, leading proprietary fundamental research-oriented boutique investment firm dedicated to investing in India. Bay Capital was established in 2006. The firm seeks to invest for the long term with a focus on delivering exceptional compound returns to its investors over time deploying a fundamental approach to equity investing in public markets. The team invests in a portfolio of businesses which are market leaders and capable of generating high returns on capital with sustainable advantages which allow them to compound earnings for a long time.

Investment Strategy

Bay Capital invests with an owner's mindset, focusing on high-quality businesses with durable competitive advantages. The strategy emphasizes long-term value creation by backing companies whose management think in decades, not quarters. We use fundamental research and a bottom-up stock-picking approach, supported by on-ground due diligence across India's diverse and complex markets. India's structural transformation—rising incomes, improved public services, and digital adoption—creates unique investment opportunities in four key themes – Consumption, Digitisation, Financialisation, and Outsourcing. Our preference lies in capital-light models delivering strong returns on capital.

Market Commentary

Indian equity markets turned positive in the month of June amidst easing geopolitical tensions. The NIFTY 50 returned +1.4% in local currency terms and +1.7% in USD terms for the month. The iShares MSCI India ETF returned +1.7% in USD terms.

On the flows front, Foreign Portfolio Investors withdrew ~\$3 billion during the month whereas Domestic Institutional Investors continued to support the markets and deployed approximately \$8 billion into Indian equities.

What a difference a quarter makes – three months is all it takes for "this time it is different" to become "why is this time like last time?"

If one marker captures the shift between March and now, it is oil. Prices have collapsed by close to 50% from their recent peaks. The Indian imported crude basket, which had touched over \$150 in mid-March, was trading at \$68.28 on July 1st. Brent tells the same story, around \$70 a barrel, down more than 40% from its \$126 peak, back to pre-war levels. The cessation of hostilities and the easing of the Strait of Hormuz blockade have turned a war-driven shortage into something closer to a supply glut.

The catalyst was simple on the surface: the U.S. President signalling that an understanding had been reached with Iran, and that peace talks were underway. That was enough to shift the mood across global markets.

We have watched this movie before and know how quickly the plot can turn, the tariff threat that briefly upended global trade, or the Russia-Ukraine war, now an almost permanent geopolitical fixture, are reminders enough. We are no macro pundits and will not forecast whether these talks hold. What we can say is that the reopening of the Strait has eased pressure on global supply chains. Trade though is stabilising; the progress of these negotiations remains a key monitorable for markets everywhere.

Closer to home, the data has been encouraging. Auto sales in June grew over 20% year on year, with passenger vehicles up more than 28%. GST collections continue to hold up. India appears to have navigated this period of instability reasonably well and the broader markets have responded in kind, and those appropriately positioned have been rewarded.

We continue to reiterate what we have said over the past several months: our discipline has been to cut through the noise and stay close to on-ground realities and the businesses we own.

Much of June kept our team out of the office and in the field. We attended four conferences and travelled to Delhi and Bengaluru, meeting a total of 50+ companies. Rather than lean on headlines, we used these meetings to hear directly how businesses are navigating the current environment and what we heard reinforced, rather than complicated, the thesis we have held for some time. Macro conditions will keep shifting. Our conviction around the fundamentals of the Indian economy, has not.

The portfolio currently comprises 39 franchises, each a market leader (among the top three) in its respective industry. Collectively, these businesses deliver both earnings growth and return on capital employed (ROCE) in excess of 20% and are currently trading at a PE of 23.2x one-year forward earnings. Their strong competitive positioning and highly scalable business models provide a long runway for sustained earnings compounding in the years ahead.

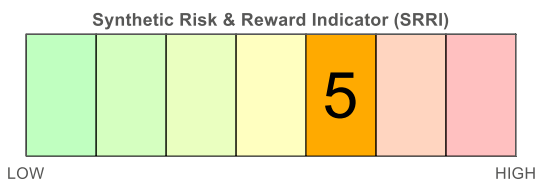

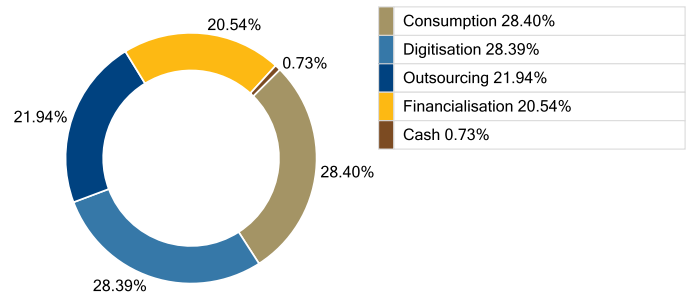
Risk Indicator
